D.A.W.G. (Dog Advisory Work Group) is a partner of the City of Chicago's Court Advocacy program, which is a part of the CAPS community policing effort. By monitoring and attending court cases that involve cruelty against animals, D.A.W.G. Court Advocates show police, court officials and offenders that community members want safe, humane neighborhoods and enforcement of laws holding abusers of all kinds accountable.

What does the presence of Court Advocates mean? It means citizens are taking a stand against violence and abuse and representing victims who cannot represent themselves. It means support for law enforcement and their community partners who intervene in these crimes. It also sends a message to offenders that we will not tolerate such crimes in our neighborhoods. Your presence, observations and awareness help ensure that these crimes against animals are treated seriously.

How You Can Help

Attend Court

Begin by going to court with an experienced D.A.W.G. Court Advocate or attending a CAPS Court Advocacy training session. Then start monitoring specific court cases online, by phone or by mail. Attend cases as little or as much as your schedule permits. *All participation helps!*

Typically, our group follows five to 10 cases weekly across Chicago and Cook County. Case outcomes are reported to our volunteer coordinators, who in turn report the information to broader audiences. You can share court successes, insights, questions and ideas for greater impact at monthly D.A.W.G. Court Advocacy meetings.

Besides expanding your knowledge, you'll also connect with other people who share the same passions and willingness to help as you.
